AND WE HEREBY further covenant and agree that we will, at the reasonable cost and expense of the Assignee, in response to any request by the ASSIGNEE, communicate to the ASSIGNEE, its successors, legal representatives and assigns, any facts known to us regarding the invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing, reissue and foreign applications, make all rightful oaths, and generally do everything possible to aid the ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper protection for the invention in all countries.

The undersigned hereby grant(s) the law firm of Straub & Pokotylo, and any other representative of the Assignee, the power to insert on this Assignment any further identification, including the application serial number,

which may be necessary or desirable in order to comply with the rules of the U.S. Patent and Trademark Office for recordation of this document.


