the Commissioner of Patents and Trademarks to issue the said Letters Patent in accordance with this Assignment.

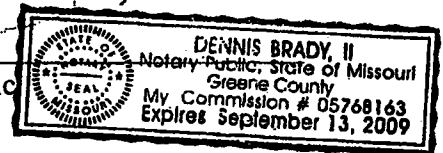

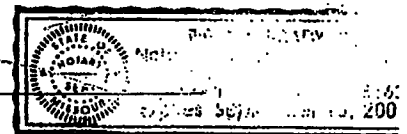
