ASSIGNMENT

WHEREAS, Philip Raymond Short, whose full post office address is 3325 First Avenue, Vineland Station, Ontario L0R 2E0 and Xie Fu Song, whose full post office address is Room 406, Flat 3 Jinyu Yuang, Shantou, China have made an invention relating to container and lid assemblies (the "Invention") for which design patent application number 29/353232 entitled LID AND CONTAINER ASSEMBLY has been filed in the United States of America and industrial design application number 133587 entitled COMBINED CONTAINER AND LID was filed in Canada, both on January 5, 2009 (collectively, the "Applications");

AND WHEREAS Philip Raymond Short and Xie Fu Song consider it to be desirable that Vortex Packaging Niagara Inc. of 3325 First Avenue, Vineland Station, Ontario L0R 2E0 be the sole owner of all rights in, to and in respect of the Invention and the Applications;

NOW THEREFORE in consideration of the sum of one Canadian dollar (CAD\$1.00) payable by Vortex Packaging Niagara Inc. to each of Philip Raymond Short and Xie Fu Song, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I, Philip Raymond Short and I, Xie Fu Song, do hereby sell, assign and transfer to the said Vortex Packaging Niagara Inc., and assign the whole right, title and interest for the United States of America, Canada and all other countries and all other places that are not countries, in, to and in respect of the Invention and in, to and in respect of all applications (including the Applications) and all Letters Patent that may be obtained therefore in the United States of America, all Industrial Design Registrations that may be obtained therefor in Canada, and all other rights that may be obtained in and for all other countries and all other places that are not countries, including all divisional, renewal, substitute, continuation, reissue, re-examination and Convention applications and any Letters Patent or design registrations to issue therefrom, together with every priority right that is or may be predicated upon or arise from the Invention, the Applications and the Letters Patent and/or Industrial Design Registrations.


AND, I, Philip Raymond Short and I, Xie Fu Song, hereby authorize Vortex Packaging Niagara Inc. to file patent applications and applications for registration of industrial designs in respect of the Invention in any countries and in any places that are not countries, and request that the United States Commissioner of Patents and Trademarks, the Canadian Commissioner of Patents, and all other patent or other authorities issue the Letters Patent, the Industrial Design Registration and any other registration to Vortex Packaging Niagara Inc., the assignee of the entire right, title and interest in and to the Invention


for its sole use and benefit; and for the use and benefit of its successors and assigns, to the full end of the term for which any Letters Patent, Industrial Design Registration or other registration in respect of the Invention may be granted, as fully and entirely as the same would have been held by me had this assignment and sale not been made.


AND, I, Philip Raymond Short and I, Xie Fu Song, hereby bind myself, legal representatives and assigns to do, upon Vortex Packaging Niagara Inc.'s request, but without additional consideration, all acts reasonably serving to assure that the Invention, the said patent applications and the said Letters Patent, Industrial Design Registration or other registration shall be held and enjoyed by Vortex Packaging Niagara Inc. as fully and entirely as the same could have been held and enjoyed by me, my legal representatives and assigns if this assignment had not been made; and particularly to execute and deliver to Vortex Packaging Niagara Inc. all lawful application documents including petitions, specifications and oaths, and all assignments, disclaimers and lawful affidavits in form and substance as may be requested by Vortex Packaging Niagara Inc.; to communicate to Vortex Packaging Niagara Inc. all facts known to me relating to said inventions and discoveries or the history thereof; and to furnish Vortex Packaging Niagara Inc. with any and all documents, photographs, models, samples and other physical exhibits in my control or in the facts or my conceptions, disclosures, and reduction to practice of the Invention.




