ASSIGNOR also hereby authorizes the United States Patent and Trademark Office to issue any and all patents or certificates of invention which may be granted upon any of the United States Patent Rights in the name of ASSIGNEE, as the assignee to the entire interest therein.

ASSIGNOR will, at the reasonable request of ASSIGNEE and without demanding any further consideration therefor, do all things reasonably necessary, proper, or advisable, including without limitation the execution and/or acknowledgment of specific assignments, oaths, declarations and other documents on a jurisdiction-by-jurisdiction basis for recordation by ASSIGNEE, to reasonably assist ASSIGNEE in obtaining, perfecting, sustaining, and/or enforcing the United States Patent Rights. Such assistance shall include ASSIGNOR using reasonable efforts to assist ASSIGNEE to obtain from the respective inventors, prompt production of documents, execution of petitions, oaths, powers of attorney, specifications, declarations or other papers and other assistance reasonably necessary for filing patent applications, complying with any duty of disclosure, and conducting prosecution, reexamination,


