CERTIFICATE OF CONVERSION

Pursuant to Section 266 of the  
DELAWARE GENERAL CORPORATION LAW

The undersigned authorized person executes and files this Certificate of Conversion this 15<sup>th</sup> day of April 2009 in order to convert Kennecott Utah Copper Corporation, a Delaware corporation (the "Corporation") into a Utah limited liability company, with effect from 1 May 2009, and does certify:

FIRST - Name of the Corporation: The name of the Corporation is Kennecott Utah Copper Corporation, and the name under which its Certificate of Incorporation was originally filed is Gazelle Corporation.

SECOND - Date of Incorporation: The date of filing of the Corporation's original Certificate of Incorporation with the Delaware Secretary of State is 10 March 1982.

THIRD - Name and Jurisdiction of Converted Entity: The jurisdiction to which the Corporation shall convert is Utah, and the name under which the converted Corporation shall be known is Kennecott Utah Copper LLC.

FOURTH - Approval of Conversion: The conversion has been duly approved by the Board of Directors and the Sole Shareholder of the Corporation.

FIFTH - Service of Process: The Corporation agrees to be served with process in the State of Delaware in any action, suit or proceeding for enforcement of any obligation of the Corporation arising while it was a corporation of the State of Delaware, and irrevocably appoints the Delaware Secretary of State as its agent to accept service or process in any such action, suit or proceeding

SIXTH - Address for Service of Process: The name and address to which a copy of the process referred to above shall be mailed by the Delaware Secretary of State is Kennecott Utah Copper LLC, 2180 South 1300 East, Salt Lake City, Utah 84106.

SEVENTH - Future Effective Date: The conversion shall become effective 1 May 2009.
