ASSIGNMENT

WHEREAS **STEPHAN J. The Assignor will without further consideration do all such things and execute all such documents as may be necessary or desirable to obtain and maintain design patents for the said design and for additions and modifications thereto in any and all countries, and to vest title thereto in the Assignee, its successors, assigns and legal representatives or nominees.

The Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks to issue said Design Letters Patent to the Assignee, for its sole use and benefit, and for the use and benefit of its successors and assigns, to the full end of the


term for which Design Letters Patent may be granted as fully and entirely as the same would have been held by me had this assignment and sale not been made.
