hereby agree that I will, upon demand of Assignee, its successors or assigns, and without further consideration to me, execute any and all papers that may be necessary, or deemed by Assignee, its successors or assigns, to be necessary, to a complete fulfillment of the intent and purposes of this Assignment, it being understood that any expense incident to the execution of such papers shall be paid by Assignee, its successors and assigns, and not by me.

This limited right granted to Robert Bosch GmbH with respect to any patent application or granted patent shall expire upon the first-occurring of (i) assignment to a third party of any of the above-mentioned rights of Assignee, or (ii) with respect to any particular patent, issue of such patent, and shall be subsequently part of the assignable rights of Assignee. All other rights to said invention, said applications and said patents, U.S. or foreign, including the right under any of said patents to manufacture, use, sell or offer for sale the invention covered by said patents, or to license or permit use of said invention, remain with Assignee and shall be assignable by Assignee without the consent of Robert Bosch GmbH.
