ASSIGNMENT

WE, Patrick Ziemle of Germany; Marcus Dapper of Germany; Christian Kopka of Germany, and Ralf Hornig of Germany, have invented a method and apparatus entitled VISUAL AID WITH THREE-DIMENSIONAL IMAGE ACQUISITION hereinafter called the "invention."


