WHEREAS


- (A) The Assignor created a design for a SHOWERHEAD ("the Design"). Representations of the Design are annexed hereto in Attachment A.

IT IS AGREED as follows:



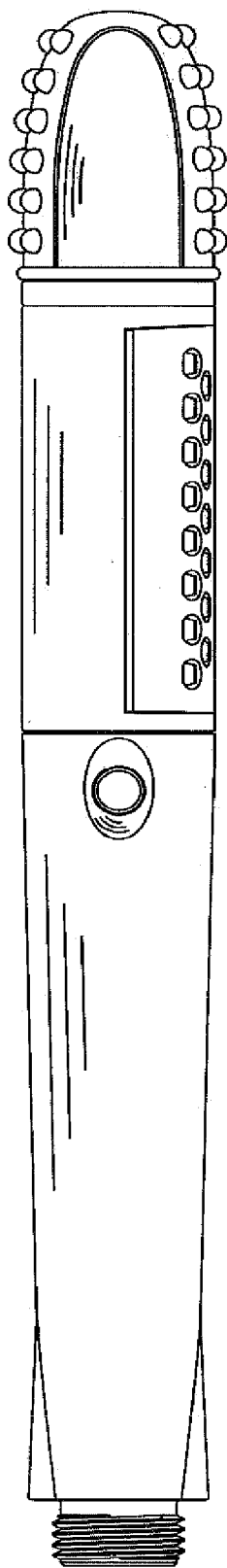

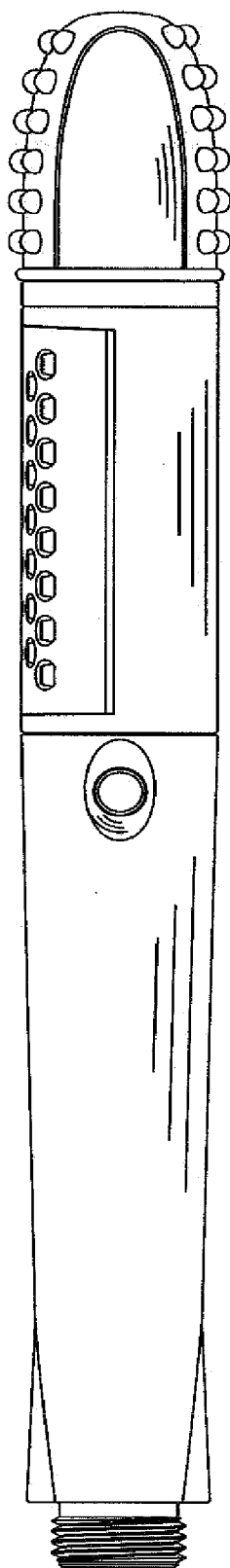

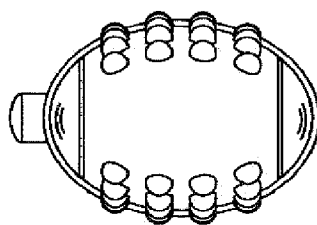

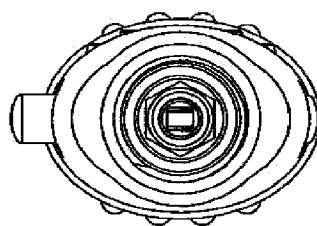

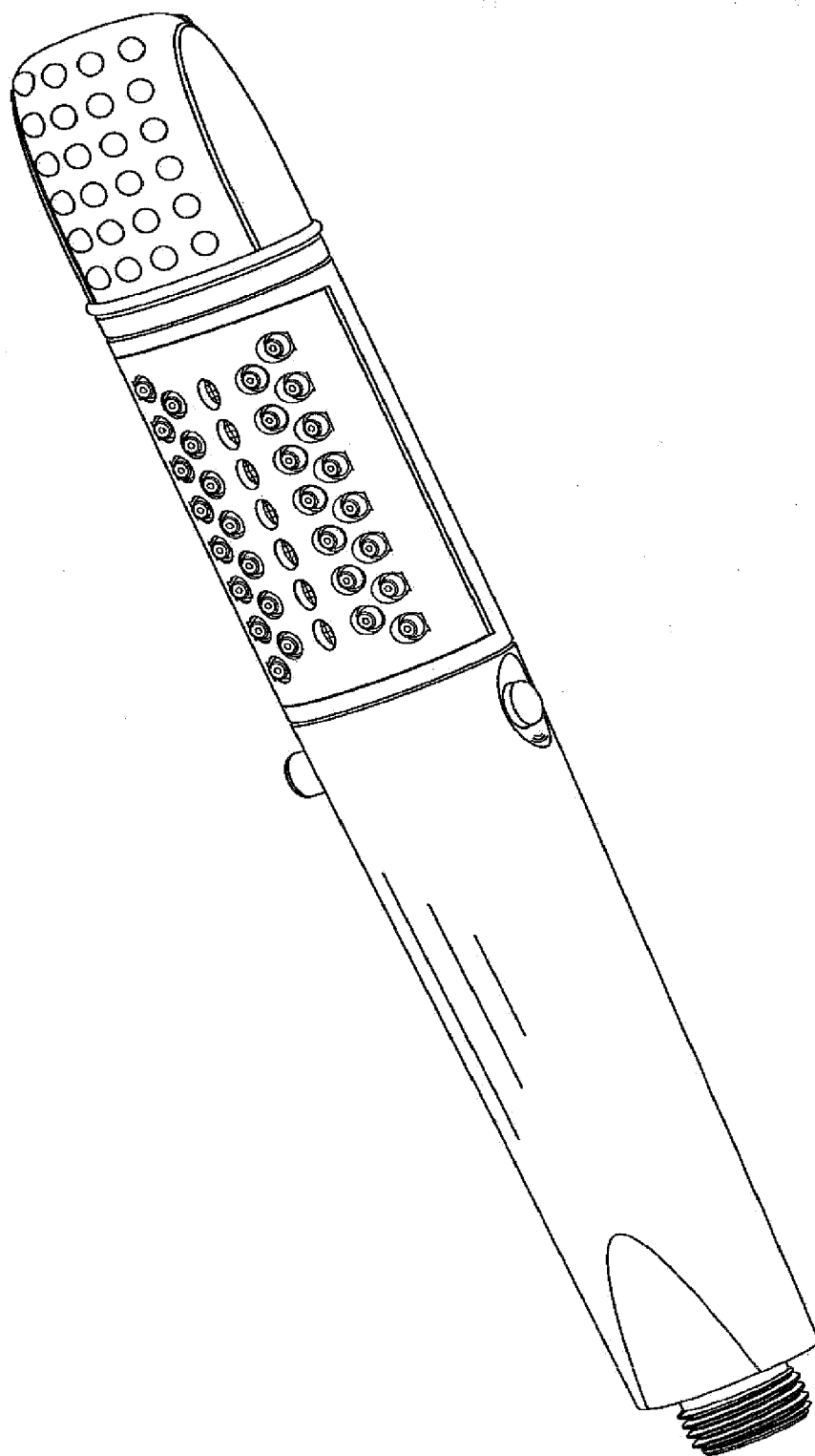

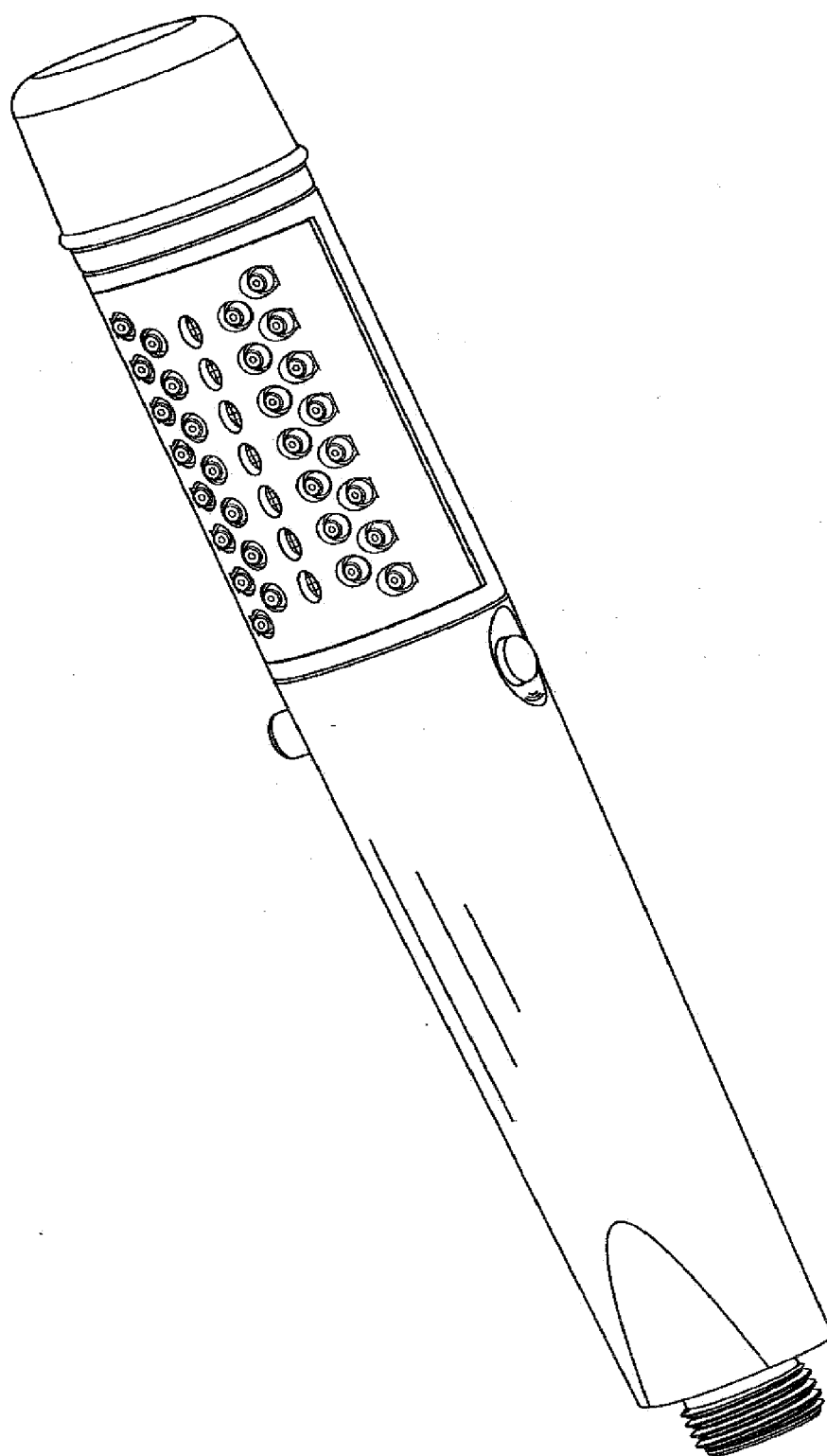
