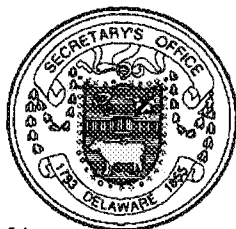



6. ARTICLE IV, Section C (4)(a)(iv)(d) of the Certificate of Incorporation of the Corporation is hereby amended to read in its entirety as follows:


"(D) shares of the Company's Common Stock (or related options) issued to current or former employees, officers and directors, consultants or other persons performing bona fide services for the Company (including, but not by way of limitation, distributors and sales representatives) pursuant to any stock offering, plan, or arrangement approved by the board;"


