**TERMINATION AND RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY RIGHTS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY RIGHTS** ("Termination and Release") is made March 26 2010 by **D.E. SHAW SURE FIT ACQUISITION HOLDINGS, L.L.C.**, and **D.E. SHAW AQ-SP SERIES 2-04, L.L.C.**, (collectively "D.E. Shaw"), to confirm the satisfaction and grant back of certain security interests in intellectual property formerly granted to D.E. Shaw by **SURE FIT INC.** ("Sure Fit").

WITNESSETH:

WHEREAS, Sure Fit entered into an agreement with D.E. Shaw that included the grant of a security interest recorded in the United States Patent and Trademark Office ("USPTO") on April 18, 2006 at Reel 017480, Frame 0739, and another agreement that included the grant of a security interest recorded on February 7, 2007 at Reel 018866, Frame 0241 and in the U.S. Copyright Office against certain Intellectual Property Collateral (as defined below) then owned by Sure Fit that had been pledged by Sure Fit as collateral security for the payment and performance of certain obligations of Sure Fit to D.E. Shaw;

WHEREAS, pursuant to that certain Consent, Waiver and Release Agreement (the "Release Agreement") dated December 30, 2009 between Sure Fit and D.E. Shaw, D.E. Shaw terminated, released and discharged its said security interest in the Intellectual Property Collateral; and

WHEREAS, the Release Agreement omitted any express reference as to the Intellectual Property Collateral, and D.E. Shaw desires to provide to Sure Fit and its successors and assigns confirmation of the termination and release the entirety of D.E. Shaw's security interest as to all of the Intellectual Property Collateral for the purpose, *inter alia*, of having such confirmation filed with the USPTO and the U.S. Copyright Office.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, D.E. Shaw hereby acknowledges and agrees as follows:

1. Definitions.

The term "Intellectual Property Collateral" as used herein, shall mean all of the right, title, and interest of every kind and nature as of the date hereof in each of the patents, trademarks, copyrights, licenses, and know how (including, without limitation, those items listed in Schedule A hereto) that are or may be subject to the grant of a security interest recorded in the USPTO on April 18, 2006 at Reel 017480, Frame 0739 and on February 7, 2007 at Reel 018866, Frame 0241 and in the U.S. Copyright Office.

2. Release of Security Interest.

D.E. Shaw hereby confirms the termination, release and discharge of its security interest in the Intellectual Property Collateral as well as any all rights secured therein by the SECURITY AGREEMENTS recorded on April 18, 2006 and on February 7, 2007 without representation,

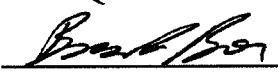
warranty, or recourse of any kind or nature. All right and title in and to the Intellectual Property Collateral hereby reverts to Sure Fit and its successors and assigns, including without limitation Sure Fit Inc., a Delaware corporation formerly known as Sure Fit Acquisition, Inc. D.E. Shaw acknowledges that this Termination and Release is being given for good and valuable consideration and in furtherance of D.E. Shaw's obligations under the Release Agreement.
