TURBOCHARGER AND VARIABLE-NOZZLE CARTRIDGE THEREFOR

And Assignors do hereby request and authorize the Commissioner of Patents and Trademarks, U.S.A., to issue said U.S. Letters Patent, when granted, in accordance with this assignment.

Assignors further covenant and agree with the Assignee that Assignors have a full and unencumbered title to the invention hereby assigned, which title Assignors warrant unto the Assignee, and Assignors further agree that Assignors will, without demanding any further consideration therefor, at the request but at the expense of the Assignee, do all lawful and just acts, including the execution and acknowledgment of instruments, that may be or become necessary for obtaining, sustaining, extending, reissuing or reexamining United States and foreign Letters Patent or the like for the said invention, and for maintaining and perfecting the Assignee's right to said invention, and for maintaining and perfecting the Assignee's right to said invention and Letters Patent particularly in cases of interference, conflict, opposition and litigation.




