ASSIGNMENT

WHEREAS, We, James H. Brauker, a United States citizen, residing at 10831 Riesling Drive, San Diego, CA 92131, Victoria Carr-Brendel, a United States citizen, residing at 3735 Grillo Court, Pleasanton, CA 94566, Paul V. Goode, a United States citizen, residing at 417 Jamaica Drive, Cherry Hill, NJ 08002, Apurv U. Kamath, a United States citizen, residing at 143 S. Rios Avenue, Solana Beach, CA 92075, James P. Thrower, a United States citizen, residing at 10176 Embassy Way, San Diego, CA 92126, and Ben Xavier, a United States citizen, residing at 702 Ash Street, #206, San Diego, CA 92101, have invented certain new and useful improvements in a SIGNAL PROCESSING FOR CONTINUOUS ANALYTE SENSOR for which we have filed an application for Letters Patent in the United States, Application No. 11/007,920, Filed on December 8, 2004;

AND WHEREAS, DexCom, Inc. (hereinafter "ASSIGNEE"), a Delaware Corporation, with its principal place of business at 5555 Oberlin Drive, San Diego, CA 92121, desires to acquire the entire right, title, and interest in and to the said improvements and the said Application:

AND WE DO HEREBY sell, assign, transfer, and convey to ASSIGNEE, his successors, legal representatives, and assigns all claims for damages and all remedies arising out of any violation of the rights assigned hereby that may have accrued prior to the date of assignment to ASSIGNEE, or may accrue hereafter, including, but not limited to, the right to sue for, collect, and retain damages for past infringements of the said Letters Patent before or after issuance.

AND WE HEREBY covenant and agree that we will communicate to the said ASSIGNEE, its successors, legal representatives and assigns, any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.
