ASSIGNORS hereby authorize and request attorneys for the ASSIGNEE to insert the filing date and application number of said application, when known, in the appropriate space provided above.


ASSIGNORS hereby covenant that no assignment, sale, agreement or encumbrance has been made or will be made or entered into which would conflict with this assignment and sale.
