WHEREAS, WE, FRANK D. HARPER, a citizen of the United States residing at 1355 Wild Rose Lane, Neenah, Wisconsin 54956; JOSEPH H. AND ASSIGNORS HEREBY authorize and request the Commissioner for Patents or any other proper officer or agency of any country whose duty it is to issue patents on applications as described above, to issue all said Letters Patent to GPCP, as assignee;

AND ASSIGNORS HEREBY warrant and covenant that we have full right to convey the entire interest herein assigned and that we have not executed and will not execute any instrument or assignment in conflict with this Assignment;

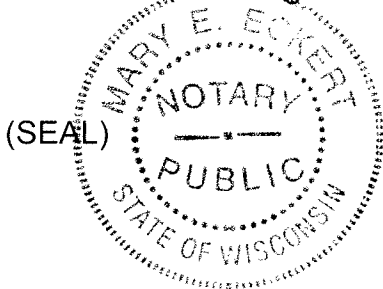
