OF****PHELPS DODGE CORPORATION***Under Section 805 of the Business Corporation Law*

I, Douglas N. Currault II, being the Secretary of Phelps Dodge Corporation, a corporation formed under the laws of the State of New York (the "Corporation"), to effect the amendment of the Certificate of Incorporation of the Corporation, do hereby certify as follows:

1. The name of the Corporation is Phelps Dodge Corporation. The name under which the Corporation was formed was Copper Queen Consolidated Mining Company.
2. The Certificate of Incorporation of the Corporation was filed with the Department of State of the State of New York on August 10, 1885. A Restated Certificate of Incorporation was filed with such Department on May 1, 2007.
3. The Certificate of Incorporation is hereby further amended in accordance with Section 801 of the Business Corporation Law to change the Corporation's name.
4. Article FIRST of the Certificate of Incorporation of the Corporation as amended and supplemented to date, relating to the corporation name is hereby amended to read as:

"FIRST: The name of the Corporation is Freeport-McMoRan Corporation."

5. In accordance with the applicable provisions of Section 708 and Section 807 of the Business Corporation Law of the State of New York, in lieu of a meeting and vote of the board of directors, the sole director of the Corporation has given written consent to approve this Certificate of Amendment and to recommend that the sole shareholder of the Corporation adopt this amendment of the Corporation's Certificate of Incorporation.
6. In lieu of a meeting and vote of the sole shareholder, the sole shareholder of the Corporation has given written consent to adoption of this Certificate of Amendment in accordance with the applicable provisions of Section 615 and Section 803 of the Business Corporation Law of the State of New York.

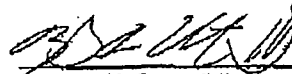
