and the use and behalf of their respective successors, legal representatives, and assigns, to the full end of the term or terms for which Letters Patent or Patents may be granted as fully and entirely as the same would have been held and enjoyed solely by the Assignor had its sale and assignment not been made,

AND the Assignor hereby requests the Commissioner of Patents to issue any and all said Letters Patent or Patents of the United States to the Assignor and Assignees and the Letters Patent or Patents issued and to be issued thereon for the undivided use and behalf of the Assignor, its successors, legal representatives, and assigns, and the Assignee, its successors, legal representatives, and assigns.





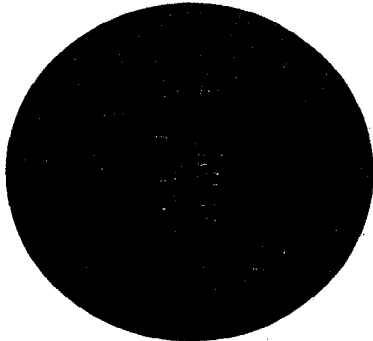
