The Office of the Commercial Register of the Canton Aargau (Switzerland) certifies:

- The company **Sprecher & Schuh AG** having its registered office at Aarau, established April 15, 1908, has taken over, as the result of a merger, the assets of the company "Maxim A.G. Fabrik für thermo-elektrische Apparate", at Aarau (company register of companies NF VIII 186) according to the balance sheet of November 30, 1970 and merger agreement of December 23, 1970.
- The company changed its name according to the articles of association of April 25, 1986 to **Sprecher Energie AG**, new place of business at Oberentfelden (CH-400.3.925.055.0).
- According to the articles of association of November 24, 1993, the company changed its name to **GEC Alsthom T&D AG**.
- Merger: By means of a merger according to Art. 748 OR, the Company, took over the company "GEC Alsthom Sales Network SA", at Oberentfelden (CH-400.3.018.439-0). The assets of CHF 27,055,335.- and the liabilities of CHF 23,731,128.- have been transferred, according to the merger agreement of July 29, 1997 and the merger balance of March 31, 1997, by universal succession to the company, which already owned the totality of shares of the company absorbed. These shares were cancelled and the share capital of the absorbing company remained unchanged.
- Simultaneously, the company changed its name, according to the articles of association of July 29, 1997 to **GEC Alsthom AG** and then, according to articles of association of June 10, 1998, to **ALSTOM AG**, at Oberentfelden.
- Merger: By means of a merger according to Art. 748 OR, the Company took over the company "ALSTOM T&D Systems AG", at Oberentfelden (CH-400.3.010.783-0). The assets of CHF 53,041,616.92 and the liabilities of CHF 42,688,723.10 have been transferred, according to the merger agreement of June 1, 1999 and the merger balance of March 31, 1999, by universal succession to the company, which already owned the totality of shares of the company absorbed. These shares were cancelled and the share capital of the absorbing company remained unchanged.

- By resolution of the general meeting of shareholders of December 22, 2000, the company **ALSTOM AG** at Oberentfelden (CH-400.3.925.055-0) was wound up and struck off, as a result of the merger according to Art. 748 OR with the company "ALSTOM Power (Schweiz AG)" from now on **ALSTOM (Schweiz) AG**, at Baden (CH-400.3.008.848-1). The assets and liabilities were transferred to the company "ALSTOM Power (Schweiz) AG" from now on **ALSTOM (Schweiz) AG**, at Baden (CH-400.3.008.848-1°).
