

4.4 Governing Law. This Agreement shall be governed by the laws of the State of Texas applicable to Agreements made and fully performed in Texas by Texas residents.

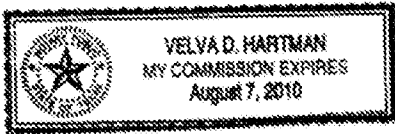

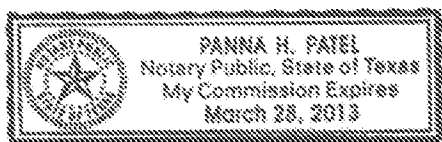
