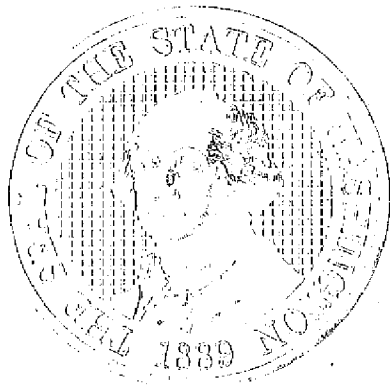





## AGREEMENT AND PLAN OF MERGER

This Agreement and Plan of Merger sets forth the terms and conditions under which Broadband Graphics, LLC, a California limited liability company ("Nonsurviving Entity"), will merge with and into Broadband Graphics, LLC, a Washington limited liability company ("Surviving Company").

### SECTION 1 DEFINITIONS

"**Dissenting Member**" means a member of Surviving Company or Nonsurviving Entity who timely asserts the member's statutory right to dissent from the merger and obtain payment for the member's ownership interest.

"**Effective Time**" means the latest to occur of the following:

- (a) the effective time and date of appropriate Articles of Merger filed with the Washington Secretary of State; and
- (b) the effective time and date of an appropriate Certificate of Merger filed with the California Secretary of State.

### SECTION 2 MERGING ENTITIES

The merging entities will be:

### SECTION 3 SURVIVING ENTITY

The surviving entity will be Broadband Graphics, LLC, a Washington limited liability company.

### SECTION 4 MATERIAL TERMS AND CONDITIONS

- 4.1 **Merger.** At the Effective Time, Nonsurviving Entity will merge with and into Surviving Company and the separate existence of Nonsurviving Entity will cease.
- 4.2 **Certificate of Formation.** The certificate of formation of Surviving Company before the Effective Time will continue to be the certificate of formation of Surviving Company after the Effective Time.

### SECTION 5 CONVERSION OF OWNERSHIP INTERESTS

The following will occur at the Effective Time:

- 5.1 **Conversion.** Except as otherwise provided in this Section 5, each 1% ownership interest in Nonsurviving Entity will be converted into a 1% ownership interest in Surviving Company.



5.2 **Dissenters' Rights.** Any shares owned by a Dissenting Member will be converted into the right to receive such payment as may be determined by the applicable dissenters' rights statute and other applicable law.


**SECTION 6 ABANDONMENT**

At any time before the Effective Time, this Agreement and Plan of Merger may be abandoned by the members of Surviving Company or by the members of Nonsurviving Entity.
