Assignor hereby authorizes the Commissioner of Patents and Trademarks of the United States, and any official of any other country empowered to issue patents, to record this Assignment, and to issue or transfer all said Letters Patent on said inventions to the Assignee as owner of all right, title and interest therein, or otherwise as the Assignee may direct, in accordance with the terms of this Assignment.

Assignor represents and warrants that Assignor has the full right to convey the entire right, title and interest herein assigned, that there are no rights, title or interests outstanding inconsistent with the rights, title and interests assigned herein, and the Assignor will not execute any instrument or grant or transfer any rights, title or interests inconsistent with the rights, title and interests assigned herein.

Should any provision of this Assignment be declared invalid for any reason, said provision shall be severed and all other provisions shall continue to be effective and binding.

This Assignment may be executed in any number of counterparts, each of which shall be an original, but all of which together shall constitute one instrument. For purposes of this Assignment, facsimile and electronically transmitted signatures shall be deemed to be originals for all purposes.

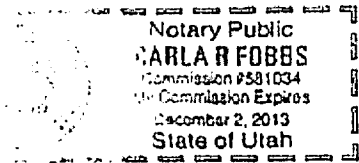
