AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith.

AND I HEREBY further covenant and agree that I will communicate to said Polylok Inc., its successors, legal representatives and assigns, any facts known to me respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths, and generally do everything possible to aid said Polylok Inc., its successors, legal representatives and assigns to obtain and enforce proper patent protection for said improvements in all countries.

AND I HEREBY further assign and transfer to Polylok Inc. all priority rights derived from such application therefor by virtue of the International Convention for the Protection of Industrial Property for any and all member countries of the aforesaid International convention and I do hereby assign and transfer to Polylok Inc. the sole right to file further applications for patents under the patent laws of any country of the world based on any improvements disclosed in said application as fully and entirely as the same would have been held by me had this assignment not been made.

AND POLYLOK INC. HEREBY assumes all right, title, and interest in and to this application and the improvements disclosed therein, any Letters Patents or reissues or reexamined patents that may be granted upon said application, to the end of the term or terms for which such Letters Patent are or may be granted or reissued or reexamined.
