ASSIGNMENT

WHEREAS, We, Federico ZARDI of Via Lucino, 60, CH-6932 Breganzona, Switzerland and Sergio DEBERNARDI of Via Roncaccio, CH-6913 Carabbia, Switzerland, have made certain inventions which are described in U.S. Patent Application No. 12/679,827 entitled PROCESS AND PLANT FOR UREA PRODUCTION executed by us on even date herewith preparatory to obtaining United States Letters Patent therefor, and

We further grant to Assignee, its successors and assigns, the right to claim for any of said applications the full benefits and priority rights of any international agreement between the United States and any foreign country or countries.

We hereby warrant that we have the full right to make the conveyance herein, and we hereby covenant that we, our heirs, legal representatives and assigns, will when requested, communicate to Assignee, its representatives, successors and assigns, all facts known respecting said inventions, execute all divisional, continuing, reissue, reexamination and foreign or international applications, together with individual assignments therefor, make all rightful oaths, sign all lawful papers, testify in any legal proceeding and generally do everything possible to aid Assignee, its successors and assigns, in the obtaining of Letters Patent.
