Letters Patent which may be granted for said improvements in any country or countries foreign to the United States and all extensions, renewals and reissues thereof.

We do hereby covenant and agree, for ourselves, heirs and legal representatives, that we will assist said **Banlaw Pty Ltd** in the prosecution of the application herein identified; in the making and prosecution of any other applications for Letters Patent that said **Banlaw Pty Ltd** may elect to make covering the invention herein identified, as hereinbefore set forth; in vesting in said **Banlaw Pty Ltd**, like exclusive title in and to all such other applications and Letters Patent; and in the prosecution of any interference which may arise involving said invention, or any application or Letters Patent herein contemplated; and that we will execute and deliver to said **Banlaw Pty Ltd**, any and all additional papers that may be requested by said **Banlaw Pty Ltd**, to fully carry out the terms of this assignment.

And we do hereby authorize and request the Commissioner of Patents to issue all Letters Patent of the United States that may be granted pursuant to application aforesaid, or for said invention, to said **Banlaw Pty Ltd**, its successors and assigns in accordance with this assignment.

And we hereby covenant that we have full right to convey the entire interest herein assigned, and that we have not executed and will not execute any agreement in conflict herewith.
