Assignor agrees without further consideration to execute all papers and documents and perform any act which may be necessary in connection with protecting the Patent Rights under any claims or provisions of the International Convention for Protection of Industrial Property or similar agreements.

Assignor agrees without further consideration to execute all papers necessary in conjunction with any interference which may be declared concerning any patent application within the Patent Rights, and to cooperate with Assignee in every way possible in obtaining evidence and going forward with such interference.
- 7. Assignor agrees to assist Assignee with respect to any infringement action, suit, or proceeding relating to the enforcement and/or protection of any of the Patent Rights.
- 8. Assignor hereby authorizes and requests the Commissioner of Patents to issue any and all Letters Patent of the United States resulting from any patent application within the Patent Rights to Assignee, as the assignee of the entire interest therein.
- 9. This agreement is binding upon and inures to the benefit of the successors and assigns of the parties.

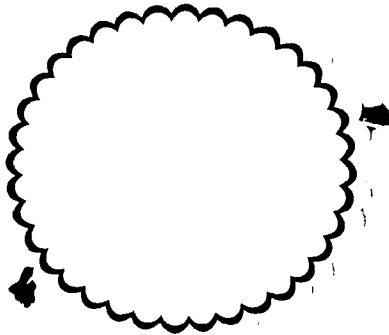
