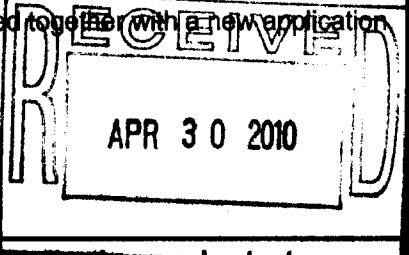


THEREFORE:
