AND WE HEREBY covenant and agree with ASSIGNEE, its successors and assigns, that we have the full right to convey the entire interest assigned herein, and that we have not executed, and will not execute, any agreement in conflict herewith, and that we will not do any other act whatsoever conflicting with these presents, and that we or our successors, assigns, executors, or administrators will at any time upon request, without further or additional consideration, but at the expense of ASSIGNEE, its successors and assigns, communicate to ASSIGNEE, its successors and assigns, any facts known to ASSIGNORS respecting said invention, and testify in any legal proceedings, sign any lawful papers, execute any original, divisional, continuation, and continuation-in-part applications, make any rightful oaths or declarations, and generally do such additional acts as ASSIGNEE, its successors and assigns,
