ASSIGNMENT

WHEREAS, WE, **Gadi PIRAN**, a citizen of the United States, residing at 39 Senator Levy Drive, Suffern, NY 10901; **Shmuel DIAMANT**, a citizen of Israel, residing at 735 Kappock Street, Apt. 5C, Bronx, NY 10463; and **Morten NIELSEN**, a citizen of Denmark, residing at 601 West 57th Street Apt. 8S, New York, NY 10019, hereinafter referred to as ASSIGNORS, have invented certain new and useful improvements in METHOD AND SYSTEM FOR VIDEO COLLECTION AND ANALYSIS THEREOF for which WE filed U.S. Patent Application No.12/414,035, filed on March 30, 2009, with the United States Patent and Trademark Office, which claims priority to U.S. Provisional Application No. 61/040,468, filed March 28, 2008;

AND WE HEREBY covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith.

AND WE HEREBY grant to Lawrence Rosenthal, Steven B. Pokotilow, Matthew W. Siegal, Brian M. Rothery, David L. Schaeffer, Ian G. DiBernardo, Angie M. Hankins, Richard Eskew and Charles E. Cantine, attorneys with the firm of Stroock & Stroock & Lavan LLP, the right and full power of attorney to enter all further identifying information of the improvements and the application as may be deemed necessary or desirable for the recordation or perfection of this Assignment.

AND WE HEREBY further covenant and agree that we will communicate to the ASSIGNEE, its successors, legal representatives and assigns, any facts known to us respecting the improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for the improvements in all countries.


