ASSIGNMENT

We, Scott R. Watterson of Logan, Utah, William T. Dalebout of Logan, Utah and Darren C. Ashby of Richmond, Utah, have invented a method and apparatus entitled SYSTEMS FOR INTERACTION WITH EXERCISE DEVICE, hereinafter called the "invention."




