PATENT ASSIGNMENT AGREEMENT

WHEREAS, Phoenix Technologies Ltd., a Delaware corporation ("ASSIGNOR") owns certain patent applications and/or registrations, as listed in Exhibit A attached hereto and incorporated herein by this reference ("PATENTS"); and

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration paid by ASSIGNEE to ASSIGNOR under the APA, the receipt and sufficiency of which hereby is acknowledged, ASSIGNOR does hereby sell, assign, transfer and convey unto ASSIGNEE its entire right, title and interest in and to the PATENTS, including, without limitation the right to apply for any all divisionals, continuations, continuations-in-part, reexaminations, substitutions, reissues, extensions and renewals of the applications and registrations for such PATENTS); all rights to causes of action and remedies related thereto (including, without limitation, the right to sue for past, present or future infringement and damages, misappropriation or violation of rights related to the foregoing); any and all other rights and interests related to the PATENTS; and the right to otherwise fully and entirely stand in the place of ASSIGNOR in all matters related to such right, title and interest. ASSIGNOR agrees, at ASSIGNEE's expense, to take such further action and to execute such additional documents as ASSIGNEE may reasonably request to carry out and fulfill the purposes and intent of this Patent Assignment Agreement ("Assignment"), including but not limited to all actions necessary or desirable to record and perfect ASSIGNEE's interest in and to the PATENTS.

ASSIGNOR hereby irrevocably constitutes and appoints ASSIGNEE as ASSIGNOR's full and lawful attorney, with full power of substitution, in its name or otherwise, to sign all documents, instruments, or agreements and to take any other actions ASSIGNEE chooses to take, in its sole discretion, with respect to the PATENTS.

ASSIGNOR hereby authorizes and requests the US Patent & Trademark Office, and any other official or agency throughout the world whose duty it is to register and record ownership in patent registrations and applications for registration, to record ASSIGNEE as assignee and owner of the PATENTS.

This Assignment is entered into pursuant to the APA, to which reference is made for a further statement of the rights and obligations of ASSIGNOR and ASSIGNEE with respect to the PATENTS and shall not be construed to limit or expand the rights of any party under the APA. Notwithstanding anything contained herein to the contrary, to the extent that any provision of this Assignment is inconsistent or conflicts with the APA, the APA shall control.

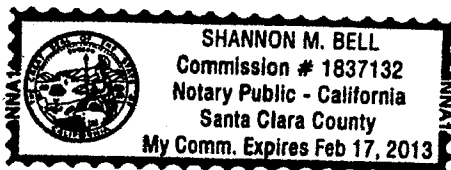

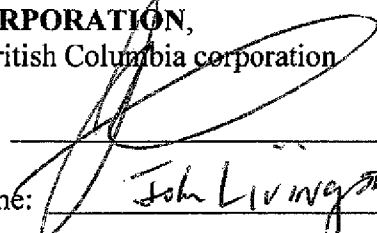

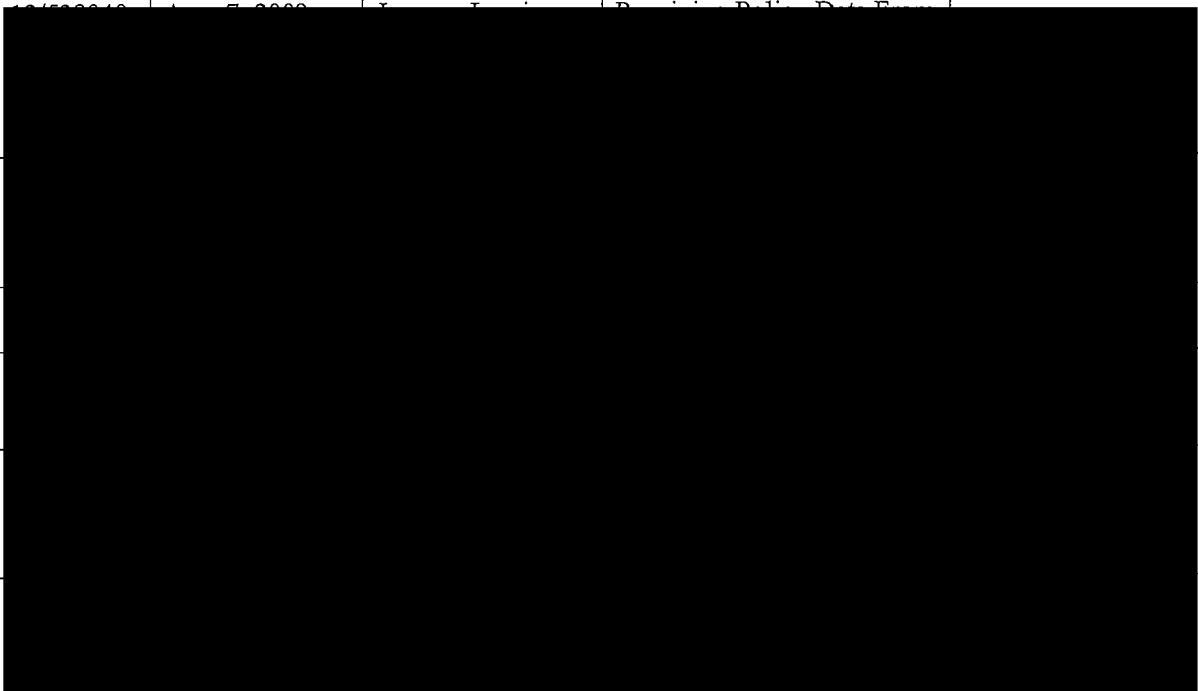
