AND, PAS HEREBY further covenants and agrees that PAS, through its officers and employees, will, without further consideration, communicate with PASD, its successors and assigns, any facts known to PAS and its officers and employees respecting the invention and testify in any legal proceeding, sign all lawful papers when called upon to do so, execute and deliver all papers that may be necessary or desirable to perfect the title to the invention in said PASD, its successors and assigns, execute all divisional, continuation, and reissue applications, make all rightful oaths, and generally do everything possible to aid PASD, its successors and assigns, to obtain and enforce proper patent protection for the invention in the United States and any foreign country, it being understood that any expense incident to the execution of such papers shall be borne by PASD, its successors and assigns.
