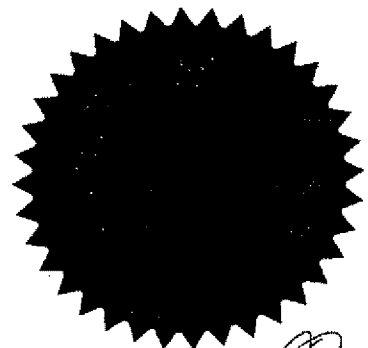
WHEREAS

The ASSIGNOR hereby records and agrees that hereafter all rights in and to the PATENT APPLICATION, and in and to the INVENTION, shall vest exclusively in the ASSIGNEES, who shall be entitled to exploit the INVENTION in the Republic of South Africa for their own benefit, and to file patent applications in respect of the INVENTION in any country they may select, and to exploit the INVENTION therein for their own benefit.






