is the owner of certain new and useful improvements in a shipping and storage container for laptop computers ("Invention"), for which U.S. Patent No. 6,305,539 has issued; and



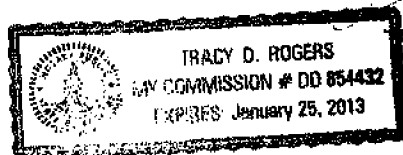


