AGREEMENT OF SALE, TRANSFER AND ASSIGNMENT
DATED AS OF July 28th, 2009

BETWEEN: 4273338 CANADA INC., a duly incorporated company, having its head office located at 600 de Maisonneuve Boulevard, Suite 2200, Montreal, Québec H3A 3J2, herein acting and represented by its President, Mr. Rob J. Teunissen, duly authorized

(hereinafter called "Assignor")

AND: WIFIN AG,

having its head office located at Grabenstrasse 25, CH-6340 Baar (ZG), Switzerland, herein acting and represented by its Director, Mr. Manuel Vogel, duly authorized

(hereinafter called "Assignee")

WHEREAS:

The Assignor is the owner of certain patents and patent applications (the "Patents"), the details of which are described more fully below;

The Assignor wishes to assign and transfer to the Assignee, who wishes to acquire all rights, title and interest to the Patents from the Assignor upon the terms and conditions set out in this Agreement;

NOW THEREFORE THE PARTIES HEREBY AGREE AS FOLLOWS:

1. The preamble hereto shall form an integral part of this Agreement and shall avail as if recited at length herein.

2. In consideration of the sum of **SIXTY FIVE THOUSAND EURO (EUR 65,000)**, which equals to **ONE HUNDRED THOUSAND CAD (CAD 100,000)** and other good and valuable consideration, the receipt and sufficiency of which are acknowledged, the Assignor hereby sells, assigns and transfers to the Assignee, hereby accepting, all rights, title and interest of the Assignor in and to the Patents hereinafter described, to be held and enjoyed by the Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by the Assignor had this assignment and sale not been made, including rights which the Assignor now or may in the future own, and all Letters Patent to be obtained on any continuation, division, renewal, substitute or reissue of the Patent for the full term for which the same may be granted, namely:

US patent - US 7011022B2, May 14, 2006;
US patent - US 5170708, December 15, 1992; and
US patent application 2006-0107852A1, May 25, 2006

3. The Assignor hereby represents and warrants to the Assignee, its successor, legal representative and assigns that:



no other person, firm or corporation has been granted rights of any nature or kind by it in respect to the said Patents.


4. The Assignor hereby instructs the Commissioner of Patents of the United States of America to assign the said Patents to the Assignee upon execution of these presents.
