### ASSIGNMENT

WHEREAS, Roy Curtiss, III of Paradise Valley, Arizona; Melha Mellata of Tempe, Arizona; Bereket Zekarias of Mesa, Arizona; Zhaoxing Shi of Tempe, Arizona; Christine Branger of Phoenix, Arizona; and Kenneth Roland of Mesa, Arizona; (hereinafter referred to as "ASSIGNOR"), own an invention (the "INVENTION") relating to an improvement in **RECOMBINANT BACTERIUM CAPABLE OF ELICITING A PROTECTIVE IMMUNE RESPONSE AGAINST ENTERIC PATHOGENS** (file No. 055743-410366 (M8-025)) and have executed an application for a United States patent based thereon Serial No. 12/681,721 filed April 5, 2010;

AND ASSIGNOR hereby authorize and request the Commissioner of Patents of the United States of America to issue any and all United States patents which may be granted upon said United States applications or any of them, or upon said INVENTION or any part thereof, to said ASSIGNEE;

AND ASSIGNOR, their successors and assigns, hereby agree to execute without further consideration any further lawful documents and any further assurances, and any divisional, continuing, reissue, or other applications for patents of any country, that may be deemed necessary by said ASSIGNEE fully to secure to said ASSIGNEE its interest as aforesaid in and to said INVENTION or any part thereof, and in and to said several patents or any of them;

AND ASSIGNOR hereby covenant and agree with said ASSIGNEE, its successors and assigns, that ASSIGNOR has granted no right or license to make, use, or sell said INVENTION, to anyone except said ASSIGNEE, that prior to the execution of this assignment, ASSIGNOR'S right, title and interest in said INVENTION have not been otherwise encumbered, and that ASSIGNOR has not executed and will not execute any instrument in conflict herewith.
