PATENT AND TRADEMARK ASSIGNMENT

THIS ASSIGNMENT AGREEMENT ("Agreement") is entered into by and among Abbott Laboratories, an Illinois corporation having a place of business at One Abbott Park Road, Abbott Park, Illinois 60064-3500 ("Abbott Labs"), and Abbott AG ("Abbott AG"), on the one hand, and Hospira, Inc., a Delaware corporation having a place of business at 275 N. Field Drive, Lake Forest, Illinois 60045-2579 ("Hospira") on the other hand. Abbott Labs and Abbott AG are collectively referred to as "Abbott."

RECITALS

WHEREAS, Abbott previously assigned to Hospira all of Abbott's right, title and interest in and to certain U.S. and foreign patents and trademarks.

WHEREAS, Hospira requires additional documentation to record the prior transfer of ownership of such patents and trademarks at certain Patent and Trademark Offices throughout the world.

WHEREAS, Abbott is willing to provide Hospira with written confirmation of the prior assignment of such patents and trademarks.

NOW, THEREFORE, for \$10 and such other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

AGREEMENT

1. Confirmation of Assignment of Patents and Trademarks. Abbott hereby confirms that it has sold, assigned and transferred to Hospira, and Hospira hereby confirms that it has received from Abbott, all right, title, and interest throughout the world in, to and under the Patents and Trademarks listed on Exhibit A to this Agreement. The sale of the Patents and Trademarks to Hospira included the transfer of: (i) the subject matter of all claims that may be obtained from the Patents, and all other corresponding rights that are or may be secured under the laws of the United States or any jurisdiction outside the United States, now or hereafter in effect, (ii) all divisionals, continuations, continuations-in-part and foreign counterparts of the Patents, and all current, future or abandoned patents and patent applications claiming priority from such applications in any country, and all patents which may be granted thereon, and all reissues and reexaminations thereof; (iii) the ongoing business and goodwill associated with the Trademarks; (iv) all registrations and applications for registration of the Trademarks; (v) the right to sue and recover damages for all past, present or future infringement; (vi) the right to injunctive relief; and (vii) any and all causes of action held by Abbott relating to any of the inventions or discoveries included in the Patents.
2. Counterparts. This Agreement may be executed in separate counterparts, each of which shall constitute an original and all of which, when taken together, shall constitute one agreement.

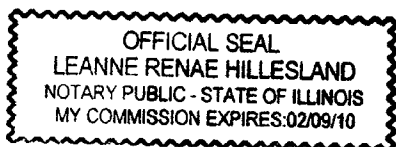

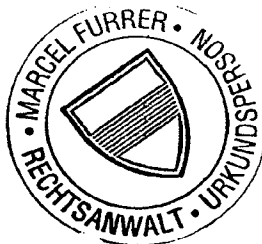
