and

(2) GD MIDEA HOLDING CO., LTD., a limited liability company incorporated under the laws of the People's Republic of China of MIDEA INDUSTRIAL CITY, PENGLAI ROAD, BEIJIAO TOWN, SHUNDE DISTRICT, FOSHAN CITY, GUANGDONG PROVINCE, 528311, PEOPLE'S REPUBLIC OF CHINA ("The Assignee")

WHEREAS

- (A) The Assignor created a design for an INTEGRAL HEAT PUMP AND HOT WATER DISPENSER (190L) ("the Design"). Representations of the Design are annexed hereto in Attachment A.
- (B) The Assignor has agreed to assign all rights in the Design to the Assignee on the terms set out herein and to execute this Assignment.












