Assignment of Intellectual Property Rights

Todd Earl Gregg ("Assignor") is the owner of proprietary and intellectual property rights, including copyrights and patents, in the concepts and technologies known as CYLINDER CART WITH LOWERING LEVER and more specifically the three-wheeled cart with lowering center castor illustrated in Attachment A to this Assignment ("Invention") and the right to registrations to the Invention; and Complete Turn Carts, LLC, organized under the laws of Indiana ("Assignee"), desires to acquire the ownership of all proprietary rights, including, but not limited to the copyrights, trade secrets, trademarks and associated good will and patent rights in the Invention and the registrations to the Invention;

Therefore, in exchange for consideration of \$3.00 for each three-wheeled cart with lowering center caster sold on or after January 1, 2010 by Assignee (or its affiliates, licensees, agents, or assigns), payable quarterly, Assignor, hereby perpetually and irrevocably assigns to Assignee all right, title and interest in the Invention, including:

- (1) all copyrights, trade secrets, trademarks and associated good will and all patents which may be granted on the Invention;
- (2) all applications for patents (including divisions, continuations in whole or part or substitute applications) in the United States or any foreign countries whose duty it is to issue such patents;
- (3) any reissues and extensions of such patents; and
- (4) all priority rights under the International Convention for the Protection of Industrial Property for every member country.

Assignor agrees to cooperate with Assignee and to execute and deliver all papers, instruments and assignments as may be necessary to vest all right, title and interest in and to the intellectual property rights to the Invention in Assignee. At Assignee's expense, Assignor further agrees to testify in any legal proceeding, sign all

lawful papers and applications, make all rightful oaths, and generally do everything possible to aid Assignee to obtain and enforce proper protection for the Invention in all countries.

Assignee's obligation to pay consideration of \$3.00 for each three-wheeled cart shall end with the expiration of the last enforceable patent claiming the lowering center castor on the three-wheeled cart illustrated in Attachment A. If no patent claiming the lowering center castor on the three-wheeled cart is granted, Assignee's obligation to pay consideration shall be reduced to \$2.00 for each cart sold when the last remaining patent application claiming the lowering center castor is abandoned.

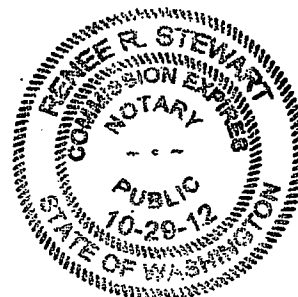

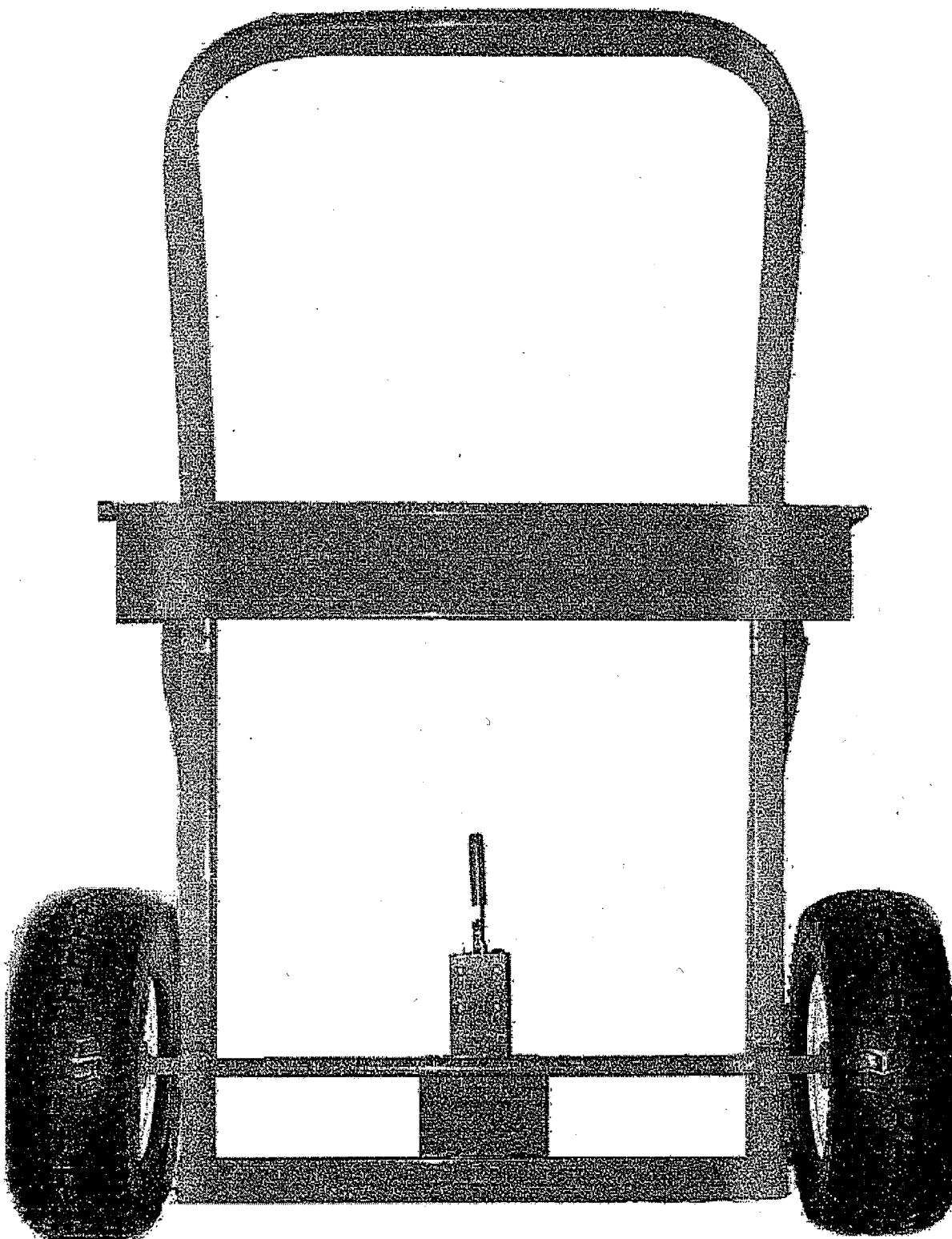

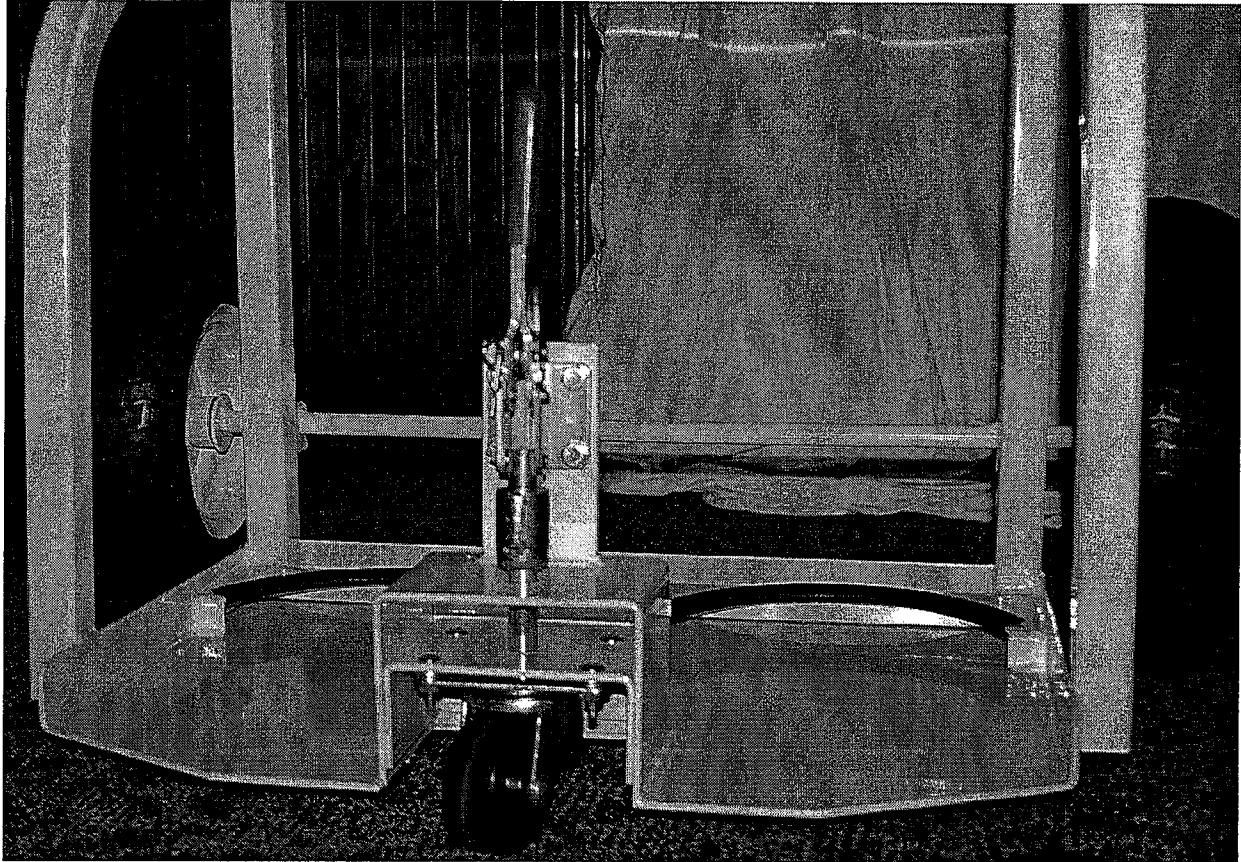

Rear View of Cylinder Cart with Lowering Lever



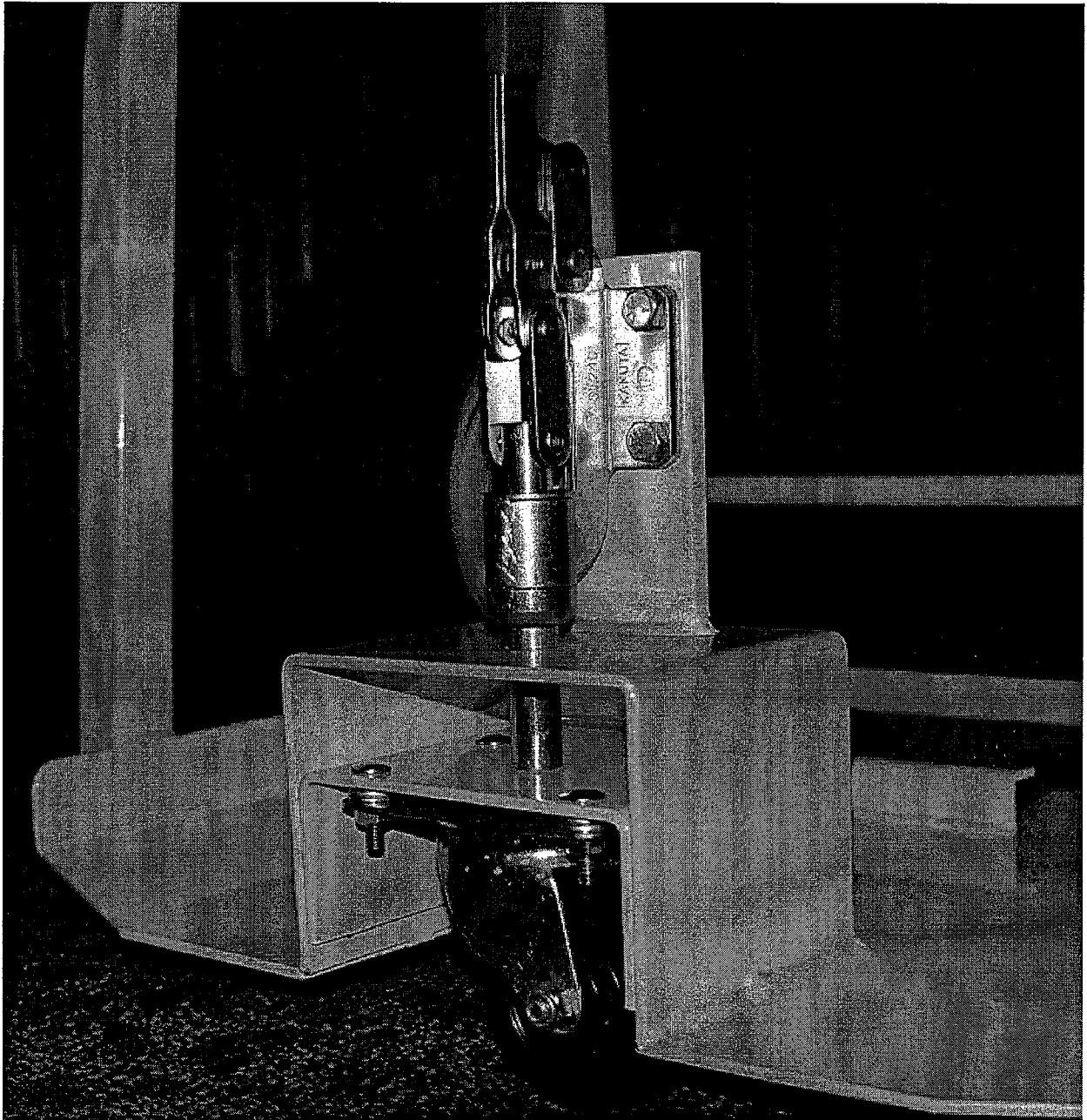
