ASSIGNMENT

HITTING POSITION DETECTING DEVICE, HITTING POSITION DETECTING METHOD, AND METHOD OF MANUFACTURING HITTING POSITION DETECTING DEVICE

which claims priority to Japan Application No. 2007-333133, filed November 27, 2007, and for which I am about to file or have filed an application for Letters Patent of the United States;
