## CONFIRMATORY ASSIGNMENT

THIS ASSIGNMENT is made the 23<sup>rd</sup> day of May Two thousand and six,

### BETWEEN

1. **PA Knowledge Limited**

whose registered office is at PO Box 309 Ugland House, George Town Grand Cayman, Cayman Islands

(hereinafter called "the Assignor") of the one part; and

2. **Meridica Limited**

a company incorporated in England under registration number 4134298 a wholly owned subsidiary of the Pfizer group of companies and having its registered office at Ramsgate Road, Sandwich, Kent CT13 9NJ and a business address at Cambridge Technology Centre, Melbourn, Hertfordshire, SG8 6DQ

(hereinafter called "the Assignee") of the other part.

### WHEREAS:

- A. By an assignment made between the Assignor and the Assignee dated 21 September 2004 (the "Assignment") the Assignor assigned intellectual property to the Assignee.

- 1. In consideration of the sum of one US dollar (\$1 US) now paid by the Assignee to the Assignor (the receipt whereof is hereby acknowledged) the Assignor HEREBY ASSIGNS with full title guarantee absolutely and free from any licenses, charges or other encumbrances all right, title and interest in and to the Applications (including any and all divisions, reissues, continuations and extensions thereof) to the intent that a grant of patents thereon shall be in the name of and shall vest in the Assignee TOGETHER WITH all the rights and powers arising or accrued therefrom including the right to sue for damages and other remedies in respect of any infringement of such rights or other rights within the scope of the claims of any published specifications accompanying the Applications prior to the date hereof.
- 2. The Assignee hereby accepts such assignment.

3. The Assignor agrees that at the request and cost of the Assignee it will at all times hereafter assist the prosecution of the Applications to grant and will assist the defence of any proceedings by way of intervention or in opposition to the grant of the patents pursuant to the Applications and will execute all such deeds and documents and do all such acts as may be necessary or desirable formally to register this Assignment at the relevant Patent Office and to render this Assignment effective under the national law of each State in which the Applications are effective and to procure the grant of patents pursuant to the Applications.
4. The Assignee shall by virtue of this assignment be entitled to the grant direct to it in its own name of the patents to be granted pursuant to the Applications.
