

actions; provided that the reasonable expenses incurred by the Inventor in providing such cooperation shall be paid for by the Assignee.



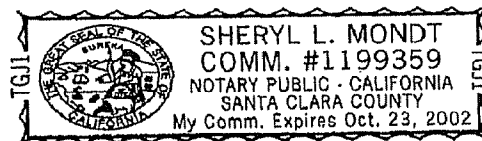
