TERMINATION OF SECURITY AGREEMENT

WHEREAS, Gichner Systems Group, Inc., a Delaware corporation, now named Gichner Systems International, Inc. (“Assignor”) executed and delivered in favor of National Penn Bank, a national banking association (“Lender”), that certain Security Agreement dated as of August 22, 2007 (the “Security Agreement”); and

WHEREAS, Assignor was the owner of the patent applications and patents (the “Patents”) listed on Schedule A attached hereto; and

WHEREAS, pursuant to the Security Agreement recorded with the United States Patent and Trademark Office on August 22, 2007 at Reel/Frame 019730/0916, Assignor granted to Lender, inter alia, a first priority security interest in and to the Patents; and

WHEREAS, Assignor subsequently assigned its interest in the Patents to Gichner Acquisition, Inc., a Delaware corporation, now named Gichner Systems Group, Inc. (“Owner”); and

WHEREAS, the parties now desire to terminate Lender’s security interest in the Patents.


NOW, THEREFORE, in consideration of the foregoing and of the mutual promises and other good and valuable consideration and intending to be legally bound hereby, Lender hereby agrees as follows:

1. Effective as of the date hereof, the Security Agreement is hereby terminated, and of no further force or effect.
2. Lender hereby acknowledges that all indebtedness and obligations of Assignor to Lender have been paid and are satisfied.
3. Lender hereby releases its security interest and conveys back to Owner all of Lender’s interest in and to the Patents.

4. Lender agrees to execute such statements or other documents, as may from time to time be determined to be reasonably necessary, to evidence the release of any and all liens or interests of record in the Patents.
