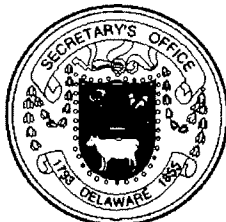

**CERTIFICATE OF AMENDMENT
OF
RESTATED CERTIFICATE OF INCORPORATION
OF
SINEXUS, INC.**

SINEXUS, INC., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "**DGCL**"), does hereby certify:

FIRST: The name of the corporation is Sinexus, Inc. (the "**Company**").

SECOND: The original name of this corporation is Sinexus, Inc. and the date of filing the original Certificate of Incorporation of this corporation with the Secretary of State of the State of Delaware is October 6, 2003.

THIRD: The Board of Directors of the Company, acting in accordance with the provisions of Sections 141 and 242 of the DGCL, adopted resolutions amending its Restated Certificate of Incorporation as follows:

1. The First Article of the Restated Certificate of Incorporation of the Company is hereby amended to read in full as follows:

"FIRST

The name of this corporation is **INTERSECT ENT, INC.** (the "**Company**")."

FOURTH: Thereafter, pursuant to a resolution by the Board of Directors, this Certificate of Amendment of Restated Certificate of Incorporation was submitted to the stockholders of the Company for their approval in accordance with the provisions of Sections 228 and 242 of the DGCL. Accordingly, said proposed amendment has been adopted in accordance with Section 242 of the DGCL.
