
**ASSIGNMENT**

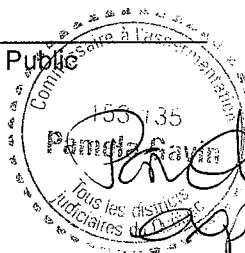
