ASSIGNMENT

This Assignment is made and entered into by and between (1) **Bahman Taheri**, residing at 3256 Lansmere Road, Shaker Heights, Ohio, (2) **Tamas Kosa**, residing at 5930 Eastham Way, Hudson, Ohio 44236, (3) **Christine Martincic**, residing at 2443 Oakwood Drive, Cuyahoga Falls, Ohio 44221, and (4) **Volodymyr Bodnar**, residing at 476 S. Francis Street, Kent, Ohio 44241, (collectively hereinafter “INVENTORS”), and **AlphaMicron, Inc.**, with its principal place of business at 1950 State Route 59, Kent, Ohio 44240 (hereinafter referred to as “ALPHAMICRON”).

Whereas, INVENTORS have invented certain inventions described in an International Patent Application entitled SOLAR POWERED VARIABLE LIGHT ATTENUATING DEVICES AND ARRANGEMENTS, filed on April 26, 2010, and later assigned International Patent Application Serial No. PCT/US10/32396, which claim the benefit of United States Provisional Patent Application entitled SOLAR POWERED VARIABLE LIGHT ATTENUATING DEVICES AND ARRANGEMENTS filed on April 24, 2009, and later assigned U.S. Patent Application Serial No. 61/172,455 (“the Patent Application”).

Now, therefore, for good and valuable consideration, receipt of which is hereby acknowledged:

1. INVENTORS hereby sell, assign, and transfer to ALPHAMICRON, its successors and assigns, the entire right, title and interest, so far as concerns the United States and the Territories and Possessions thereof and all foreign countries, in and to the Patent Application, the inventions set forth in the Patent Application, any and all other applications for Letters Patent on said inventions in the United States and in countries foreign to the United States, including all conversion, provisional, non-provisional, divisional, renewal, extension, reexamination, substitute, continuation, continuation-in-part, reissue, and Convention applications based in whole or in part upon said inventions or upon said applications, or claiming the benefit or

priority thereof, and any and all Letters Patent and reissues and extension of Letters Patent granted for said inventions or upon said applications, and every priority right that is or may be predicated upon or arise from said inventions, said applications and said Letters Patent.

2. ALPHAMICRON is hereby authorized to file patent applications in any or all countries on any or all said inventions in the name of the INVENTORS or in the name of ALPHAMICRON or otherwise as ALPHAMICRON may deem advisable, under the International Convention or otherwise.

3. The Commissioner of Patents of the United States of America and the empowered officials of all other governments are hereby authorized to issue or transfer all said Letters Patent to ALPHAMICRON in accordance herewith.

4. This Assignment is being made under covenant, not only that full power to make the same is had by the INVENTORS, but also that, at the time of execution of this Assignment, such assigned right is not encumbered by any grant, license, governmental restriction, or other right heretofore given.

5. The INVENTORS agree that they will do all acts reasonably serving to assure that said inventions, patent applications and Letters Patent shall be held and enjoyed by ALPHAMICRON as fully and entirely as the same could have been held and enjoyed by the INVENTORS if this Assignment had not been made, and particularly to execute and deliver to ALPHAMICRON all lawful documents including without limitation petitions, specifications, oaths, assignments, invention disclaimers, lawful affidavits, and declarations in form and in substance which may be requested by ALPHAMICRON, to furnish ALPHAMICRON with all facts relating to said inventions or the history thereof and any and all documents, photographs, models, samples or other physical exhibits which may be useful for establishing the facts of conception, disclosure and reduction to practice of said inventions, and to cooperate with ALPHAMICRON and counsel and testify in any proceedings relating to said inventions, patent applications and Letters Patent.

6.
