WHEREAS I, **MITJA BORKERT**, a German citizen residing at Stuttgart, Germany, have invented certain new and ornamental improvements in an

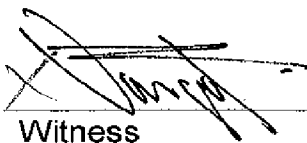
AUTOMOBILE WHEEL

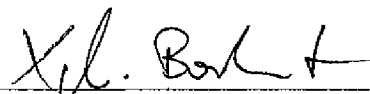
for which an application for Letters Design Patent of the United States of America was executed on the date of execution of this assignment;

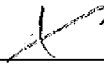
