

Section 201(b), and all rights in and to all income, royalties, damages, claims, and payments, now or hereafter due or payable with respect thereto, and in and to all causes of action, either in law or in equity for past, present, or future infringement based on the Intellectual Property, and in and to all rights corresponding to the foregoing throughout the world.

PATENTS

- The application entitled "STREAMING CONTENT PROVISIONING SYSTEM FOR WIRELESS NETWORKS" is a utility ("regular") patent application that was filed on October 10th, 2008. It generally covers the broad systems and methods for the selection and delivery of streaming content to users of mobile devices. It relates and claims priority to previously filed applications that date back to a provisional application that was originally filed on September 11, 2006. This application will be examined by the patent office, and may eventually become a patent.
