### ASSIGNMENT

WHEREAS We, LEE, Sang-yun of 104-802, Sejong APT., Jeonmin-dong, Yuseong-gu, Daejeon 305-728 Republic of Korea ; KANG, MinGu of 129-1505, Hanbit Apt., Eoeun-dong, Yuseong-gu, Daejeon 305-755 Republic of Korea ; and LIM, Ssang-gun of 107-402, Gangbyeon APT., Mamnyun-dong, Seo-gu, Daejeon 302-741 Republic of Korea(hereinafter referred to as "ASSIGNORS") have invented certain new and useful improvements in:

#### **SURFACE SHAPE MEASURING SYSTEM AND SURFACE SHAPE MEASURING METHOD USING THE SAME**

which claims priority to Korean Application No. 10-2007-0131395, filed on December 14, 2007, and for which I am about to file an application for Letters Patent of the United States;

the cost and expense of the said ASSIGNEE fully assist and cooperate in all matters in connection with the United States and foreign applications and patents issuing thereon.


