











METHOD AND DEVICE FOR PRODUCING ELECTRODES FOR BATTERIES

Whereas, Gerd FEHRMANN a citizen of Germany, Dr. Thomas FISCHER a citizen of Germany, Thomas HUCKE a citizen of Germany, Roland STAUB a citizen of Germany, Dr. Juergen DREWS a citizen of Germany, Dr. Tim TRAULSEN a citizen of Germany ("Assignors"), have conceived a certain invention entitled "**METHOD AND DEVICE FOR PRODUCING ELECTRODES FOR BATTERIES**" ("Invention") and whereas, BIOTRONIK CRM Patent AG an entity existing under the laws of Switzerland and having a place of business at Neuhofstrasse 4, CH-6341 Baar, Switzerland ("Assignee") is desirous of acquiring or has acquired the entire right, title and interest in and to the Invention and all rights relating thereto;

Assignor hereby authorize and request the Director of the U.S. Patent and Trademark Office and all foreign Patent Offices to issue Patents for the subject matter assigned herein to said Assignee, of the entire right, title, and interest in and to the same, for Assignees sole use and behoof; and for the use and behoof of Assignee legal representatives, to the full end of the term for which said Patent may be granted, as fully and entirely as the same would have been held by Assignor had this assignment and sale not been made. Assignor hereby covenants with Assignee, its successors, assigns, and legal representatives that no assignment, grant, mortgage, license or other agreement affecting the rights to the Invention herein conveyed has been made to other by the undersigned, and that the full right to convey as herein expressed is possessed by the undersigned.
