U.S. INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT  
(Canadian Grantors)

U.S. INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT, dated May 18, 2010 ("IP Security Release"), by UBS AG, STAMFORD BRANCH, a United States branch of a Swiss bank located at 677 Washington Boulevard, Stamford, CT 06901, in its capacity as collateral agent pursuant to the Credit Agreement (in such capacity, the "Assignee"), in favor of NOVELIS INC., a corporation formed under the Canada Business Corporations Act, having its business address at 3399 Peachtree Road NE, Suite 1500, Atlanta, GA 30326, ("Assignor").

W I T N E S S E T H:

WHEREAS, Assignor is a party to a Security Agreement dated as of July 6, 2007 (the "Security Agreement") in favor of the Assignee, pursuant to which Assignor executed and delivered (i) that certain U.S. Intellectual Property Security Agreement, dated as of July 6, 2007 (the "Initial IP Security Agreement"); (ii) that certain U.S. Intellectual Property Security Agreement, dated as of September 18, 2008 (the "Supplemental IP Security Agreement") and (iii) that certain U.S. Intellectual Property Security Agreement, dated as of April 20, 2009 (the "Second Supplemental IP Security Agreement") and, collectively with the Initial IP Security Agreement and the Supplemental IP Security Agreement, the "IP Security Agreements") in order to record the interest of Assignee in the IP Collateral (as defined in the IP Security Agreements) in the United States Patent and Trademark Office (the "PTO");

WHEREAS, the Initial IP Security Agreement was recorded with the Patent Division of the PTO on August 17, 2007 at Reel 019714 and Frame 0384;

WHEREAS, the Supplemental IP Security Agreement was recorded with the Patent Division of the PTO on July 2, 2009 at Reel 022909 and Frame 0549;

WHEREAS, the Second Supplemental IP Security Agreement was recorded with the Patent Division of the PTO on August 13, 2009 at Reel 023097 and Frame 0973; and

WHEREAS, Assignee now desires to release its security interest in and to the Assignors' right, title and interest in and to the IP Collateral identified in this IP Security Release.

NOW, THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignee and Assignor hereby agree as follows:

SECTION 1. Defined Terms. Capitalized terms used but not otherwise defined herein that are defined in the IP Security Agreements shall have the meanings given to them in the IP Security Agreements.

SECTION 2. Release of Security Interest in IP Collateral. Assignee hereby terminates and releases in its entirety its lien on and security interest in all of the right, title and interest of Assignor in, to and under the IP Collateral set forth on Schedule 1 attached hereto.

SECTION 3. Recordation. Assignor hereby authorizes and requests that the Commissioner of Patents and Trademarks and the United States Copyright Office record this IP Security Release.


SECTION 4. Counterparts. This IP Security Release, and any amendments, waivers, consents or supplements hereto, may be executed in any number of counterparts and by different parties hereto in separate counterparts, each of which when so executed and delivered shall be deemed to be an original, but all such counterparts together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page of this IP Security Release by telecopier shall be effective as delivery of a manually executed counterpart.

SECTION 5. Governing Law. This IP Security Release shall be construed in accordance with and governed by the law of the State of New York, without regard to conflicts of law principles that would require the application of the laws of another jurisdiction.
